

Terms and Conditions for BLiV Ltd.

1. Acceptance of Terms

By accessing or using BLiV (the "App"), you agree to comply with and be bound by these Terms and Conditions. If you do not agree with these terms, please do not use the App.

2. Eligibility

You must be at least 18 years old to use this App. By using the App, you confirm that you meet this age requirement.

3. Health Screening Feature

The App includes a health screening feature that allows you to earn \$LiV daily by staking their decentralised Non-Fungible Token (dNFT) avatar. The higher the level of the dNFT avatar, the more \$LiV users can earn. Users can also level up their avatar by either accumulating \$LiV or by participating in activities that provide level-up acceleration. This offers users an opportunity to earn \$LiV whilst interacting with the platform and participating in activities to enhance their avatar's level. By staking their dNFT avatars, users can benefit from the platform's growing ecosystem whilst simultaneously increasing their \$LiV earning potential.

You acknowledge and agree that:
